Jeff Loughridge

There is no process where the Town goes back and looks at a project and determines what was on the plans, what actually ended up being there, and whether it was a success or failure. He cited the project at 375 Knowles with its drainage system that was not in the original plans and ended up having nine feet of dirt added at the back edge, with the grade at the top of the seven-foot fence at Villa Vasona next door.

Angelia Doerner

 Questioned how many parking spaces are allocated to the building, which the applicant would share with SoulCycle, and how many are allocated to this particular space for the Parking District. Suggested a condition that those spaces be held open for additional parking for SoulCycle. Pressed Juicery's location next to SoulCycle would be great for business.
