RECOMMENDATION:

Adopt resolution accepting work of Anderson Pacific Engineering Construction, Inc. and authorizing the Town Manager to execute Certificate of Acceptance and Notice of Completion for recording by Town Clerk.

BACKGROUND:

On March 17, 2003, the Town Council approved plans and specifications for Project 02-11 - Los Gatos Creek Bridge Seismic Retrofit.

On July 7, 2003, the Town Manager during an official legislative recess, awarded the contract for this work to Anderson Pacific Engineering Construction, Inc. as the lowest responsible bidder.

On January 30, 2004 the project was substantially completed. The execution and recordation of the Certificate of Acceptance is now required to finalize the Town's acceptance of the project.

DISCUSSION:

This project funded the design and construction of improvements of two Town bridges to bring them into compliance with current State and Federal seismic safety standards. The bridges span Los Gatos Creek at Blossom Hill Road and at Lark Avenue.

WHEREAS, on March 17, 2003, the Town Council approved plans and specifications for Project 02-11 - Los Gatos Creek Bridge Seismic Retrofit; and

WHEREAS, on July 7, 2003, the Town Manager awarded the contract for the proposed work to Anderson Pacific Engineering Construction, Inc.; and

WHEREAS, during an official legislative recess from July 7, 2003 to August 4, 2003, and pursuant to authority granted by the Town Council, the Town Manager authorized staff to issue change orders to the construction contract up to an amount of \$30,000.

WHEREAS, Anderson Pacific Engineering Construction, Inc. substantially completed the project in conformance with the plans and specifications pursuant to Council approval; and

WHEREAS, ten percent of the performance bond provided by Anderson Pacific Engineering Construction, Inc. shall remain in place for two years until March 1, 2006, to guarantee the work; and

WHEREAS, the work on Project 02-11 - Los Gatos Creek Bridge Seismic Retrofit is hereby accepted as complete pursuant to the plans and specifications for the project.

NOW THEREFORE BE IT RESOLVED, that the Town Manager is authorized and directed to execute the Certificate of Acceptance and Notice of Completion attached as (Exhibit A) hereto.

BE IT FURTHER RESOLVED, that the Town Clerk is directed to transmit this Certificate of Acceptance and Notice of Completion to the Recorder of Santa Clara County for recording.
