Clarification on a time frame that the Vasona Station Corridor would be up and running. Questioned the effects on local business regarding the ½ cent sales tax increase. Commented that the permanent ½ cent sales tax is high and difficult to perceive. Clarification on the zero sales tax scenario, and what projects would continue. Commented on the widespread absence of support for the ½ cent sales tax. Commented that VTA could maintain there system with a zero sales tax increase, but with no capital projects in the near future. Commented that VTA will have more answers after the work shop in August, 2005.
