Today's Context

- Anniversary of Loma Prieta Earthquake
- Hurricanes Katrina and Rita
- Flooding in New Hampshire
- Wildland fires
- Improved Computer Modeling of Earthquake Predictions

The Emergency Preparedness System

- Field
- Local
- Operational Area (County)
- Region
- State
- Mutual Aid Network, ICS, SEMS, NIMS, Homeland Defense

Emergency Response Planning

- Pre-planning of most likely incidents
- Plans meet state standards
- Yearly exercises to test elements of response capability
 - Golden Guardian exercise in November '05

Emergency Personnel

- EOC personnel
 - Town Manager is Director
 - Police Chief is Assistant Director
 - Department Heads lead major sections
- Emergency Manager's Association & Emergency Preparedness Council
- Volunteer support of EOC and Emergency Preparedness
 - Benefits and vulnerabilities

Multi-Level Approach to Local Disaster

- Town staff, mutual aid
- DART & Volunteers
- CERT (Community Emergency Response Team)
 - Goal of self reliance

 Future potential to develop business and school emergency components like CERT

Our Experience

- Loma Prieta Earthquake
- Cats Hill Fire
- Training in domestic preparedness since 9-11

Issues to Anticipate

- Evacuation of needy
- Ingress/egress
- Acceptance and use of volunteers
- Neighborhood and business district selfreliance
- Communications & coordination within Town Staff and between agencies

- Pets/animals
- Where our staff live
- Community expectation in major disaster
 - Effective emergency response
 - Quickly move to recovery
- Limitations of existing EOC facility
- Staffing

Role of the Council

- Council plays their normal roles as community leaders and policy makers
 - Stay informed
 - Provide appropriate assurances to community as warranted
 - Ensure staff is aware of community expectations and needs as seen through the eyes of the Council
 - Make important policy decisions that aid in response or recovery
 - There is not an active role for Council in the EOC as emergency response is a staff role
