SUBJECT:

#### **DISCUSSION:**

Candidates (non-incumbents) who did not appear for interviews without prior notification are disqualified from consideration for this round of appointments.

Incumbents Sol Carson, Art Selection Panel; Tom Kane and Tom Dodge, Building Board of appeals; and William Kraus, Rent Advisory Committee were not present for interviews on October 24, 2005. These incumbents have requested to be included as part of the appointment process on November 7, 2005.
