SUBJECT: ADOPT RESOLUTION AUTHORIZING THE TOWN MANAGER TO ACCEPT A DONATION FROM THE LOS GATOS POLICE FOUNDATION IN THE AMOUNT OF \$5,348.00 FOR THE PURCHASE OF 40 MULTI-USE TRAINING MATS FOR THE POLICE DEPARTMENT.

### RECOMMENDATION:

Adopt resolution authorizing the Town Manager to accept a donation from the Los Gatos Police Foundation in the amount of \$5,348.00 for the purchase of 40 multi-use training mats for the Police Department.

### BACKGROUND:

Over the past several years, the Los Gatos Police Foundation has received private donations and conducted several fund raising events with funds specifically designated for the purchase of supplies and equipment for the Los Gatos/Monte Sereno Police Department and its volunteer groups.

During the last several years the Los Gatos/Monte Sereno Police Department has been borrowing training mats from various police departments and private organizations to use during mandated physical exercises and arrest and control training. It has become increasingly difficult to secure these mats for all the required training dates and is inefficient to transport and return mats each time.

### DISCUSSION:

The Los Gatos/Monte Sereno Police Department is committed to maintaining and improving perishable defensive tactics and arrest and control skills. To maintain this commitment and provide a high level of training the Los Gatos/Monte Sereno Police Department needs to acquire their own
