





In memory of her late husband, James Bond, owner of the James Bond Gallery, Evelyn Bond donated an oil painting to the Town. She requested that the painting be hung in the Los Gatos Public Library and arranged the donation through the Library Director.

The painting by artist W. Jonathan Custon titled "Eternal Bouquet" is currently on display in the Library above the main stairway.
