ADOPT RESOLUTION APPROVING PLANS AND SPECIFICATIONS FOR THE BACHMAN PARK IRRIGATION PROJECT AND AUTHORIZE STAFF

TO ADVERTISE THE PROJECT FOR BID

RECOMMENDATION:

Adopt Resolution approving plans and specifications for the Bachman Park Irrigation project and authorize staff to advertise the project for bid.

BACKGROUND:

Bachman Park is a hillside residential park with large grass areas and an inefficient watering system. Irregular slopes, shading, and lawn shapes leave areas wet, unusable, or too dry causing the lawn to die. The irrigation system at this park is over 40 years old and has been in need of replacement and rehabilitation for several years and has been deferred due to lack of funding.

DISCUSSION:

This project will upgrade the irrigation system at Bachman Park with a system designed to provide proper irrigation coverage for the lawn area and use new irrigation heads that are efficient and functional. The construction of this project was postponed until winter in order to minimize inconveniences to the park users during the summer months and heavy park usage.

Plans and Specifications for this project are complete and will be available for review in the Clerk Department on the Friday before the Council meeting. If Council approves this project, it will be advertised, a construction contract will be presented for Council for award on October 1, 2007, and construction is anticipated to begin in November 2007.

CONCLUSION:

ENVIRONMENTAL ASSESSMENT:

This is a project as defined under CEQA but is Categorically Exempt (Section 15301c). A Notice of Exemption will not be filed.

FISCAL IMPACT:

This project's total estimated cost was \$100,000, funded from State Bond Proposition 40 Parks grant. During FY 2006/07, design and material expenditures totalled \$7,595. The remaining balance of \$92,405 is available for construction this fiscal year. The following chart describes the project's budget:
