**ADOPT** RESOLUTION ACCEPTING THE WORK OF A CB CONSTRUCTION COMPANY AND **AUTHORIZING** THE **TOWN** MANAGER TO EXECUTE A CERTIFICATE OF ACCEPTANCE AND NOTICE OF COMPLETION FOR RECORDING BY THE CLERK

**ADMINISTRATOR** 

#### RECOMMENDATION:

Adopt a Resolution accepting the work of CB Construction Company and authorizing the Town Manager to execute a Certificate of Acceptance and Notice of Completion for recording by the Clerk Administrator.

#### BACKGROUND:

This project successfully installed wheelchair accessibility ramps at various street intersections in compliance with the American with Disability Act (ADA). This is consistent with the Town's goals to improve public health and safety and meets the eligibility requirements for the federal CDBG grant program.

#### DISCUSSION:

On March 16, 2009, the Town Council awarded a contract for this project to CB Construction Company.

The contracted work has been satisfactorily completed by CB Construction Company and is accepted by the Parks and Public Works Department.

#### (DISCUSSION cont'd)

Ten percent of the faithful performance bond will remain in effect for a period of two years to guarantee any needed repair or replacement caused by defective materials and workmanship. The execution and recordation of the Certificate of Acceptance is now required to finalize the Town's acceptance of the project. Staff recommends that the Certificate of Acceptance and Notice of Completion be executed and recorded.

#### CONCLUSION:

Staff recommends the Town Council adopt a Resolution accepting the work of CB Construction Company and authorize the Town Manager to execute a Certificate of Acceptance and Notice of Completion for recording by the Clerk Administrator.

#### ENVIRONMENTAL ASSESSMENT:

This is a project as defined under CEQA but is Categorically Exempt (Section 15301c). A Notice of Exemption will not be filed.

#### **FISCAL IMPACT**:

The original agreement approved by Council was for an amount of \$39,805. There was an additional authorized contingency amount of \$5,000, bringing the total overall authorized budget to \$44,805.

The project was completed for \$43,995 which is within the total authorized budget.
