#### RECOMMENDATION:

Adopt a Resolution accepting the work of TruGreen LandCare and authorizing the Town Manager to execute a Certificate of Acceptance and Notice of Completion for recording by the Clerk Administrator.

#### BACKGROUND:

The original project scope was to trim 143 street trees in four specific locations, and obtain itemized unit pricing for additional unanticipated or emergency work. Because of the base bid coming in lower than expected, additional tree trimming was accomplished at five park sites which reduced potential liability around playgrounds structures and picnic areas. Additional tree trimming was accomplished at the Civic Center and Neighborhood Center facilities, including the front lawn area at the Civic Center.

#### DISCUSSION:

On January 20, 2009, the Town Council awarded the contract for this project to TruGreen LandCare. The work has been satisfactorily completed by the contractor and is accepted by the Parks and Public Works Department.

#### (DISCUSSION cont'd)

Ten percent of the faithful performance bond will remain in effect for a period of two years to guarantee any defects in workmanship. The execution and recordation of the Certificate of Acceptance is now required to finalize the Town's acceptance of the project. Staff recommends that the Certificate of Acceptance and Notice of Completion be executed and recorded.

#### **CONCLUSION:**

Staff recommends the Town Council adopt a Resolution accepting the work of TruGreen LandCare and authorize the Town Manager to execute a Certificate of Acceptance and Notice of Completion for recording by the Clerk Administrator.

# **ENVIRONMENTAL ASSESSMENT:**

This is a project as defined under CEQA but is Categorically Exempt (Section 15301c). A Notice of Exemption will not be filed.

#### FISCAL IMPACT:

The agreement was approved by Council in the total amount of \$79,440. The combined expenditures under this agreement were \$77,980.
